## **University of Central Florida** Fifty-Sixth Student Body Senate Fiscal Bill 56-54

[Funding for Knight Riders Motorcycle Club to host the WERA Motorcycle Roadracing at Atlanta, Georgia on May 23rd, 2025]

WHEREAS, Knight Riders Motorcycle Club (KR) has been a Registered Student Organization 2012;

WHEREAS. The mission of KR is to is to bring unity among motorcycle riders and enthusiasts in the UCF community;

WHEREAS, KR members pay dues of \$25 semester;

WHEREAS, KR currently has 66 active members;

WHEREAS. The purpose of the WERA Motorcycle Roadracing is to allow students with advanced riding skills to go and compete at the club racing level against other people in the sport. This will allow students to learn more, network with people with similar hobbies, and further their knowledge about their motorcycles;

WHEREAS, Students competition will learn more about their motorcycles and controlling them along with making new connections that can be brought to the main campus and further educate our students;

WHEREAS, The expected turnout for WERA Motorcycle Roadracing is 6; and

WHEREAS, Knight Riders Motorcycle Club received \$3,670.99 via FAO Allocations 56-04 & 56-171, \$5,400 via FAO Fiscal Bill 56-07, and \$5,000.00 via CRT Allocations 56-035, 56-109, & 56-110 (Total: \$14,170.99) in Activity and Service Fee Funds in the 2024-2025 Fiscal Year.
