University of Central Florida Fifty Sixth Student Body Senate Internal Bill 56-34

[Updates to Title XIV: The Student Government Caucuses]

WHEREAS, Statutes require constant updates and revision to best serve the Student Body;

WHEREAS, The ex-officio seat election process is convoluted and needs simplification;

WHEREAS, The three-seat limit is arbitrary and constrains the caucus's ability to listen to all student voices;

WHEREAS, This bill streamlines the process and eliminates the limit on ex-officio seats; and

WHEREAS, This Bill will go into effect immediately.

THEREFORE, *BE IT ENACTED*, by the Fifty-Sixth Student Senate of the University of Central Florida that Title XIV be amended as follows:

Chapter 1400 Caucuses

1401.3

A. Any Student Government Agent who identifies with the mission of a Caucus.

- 1. No Student Government Agent shall be barred from membership.
- 2. Branch heads shall announce Caucus appointments for their respective branch members at the next regularly scheduled Senate meeting during their Senate report.
- B. Any Caucus member may resign by submitting a written resignation to the Caucus Chair and their branch head.
- C. No Student Government Agent shall be required to be a member of a Caucus
- D. No Student Government Agent shall serve as Chair of more than (1) Caucus.
- E. Any RSO or University Department that represents the student population or identity group that correlates with the caucus may be elected by the members of the caucus into an ex-officio seat. Three (3) ex-officio members' seats.
 - 1. The number of ex-officio seats shall not exceed the total number of Student Government agents within the caucus unless otherwise stipulated by a Caucus. One (1) permanent ex-officio member seat is to be filled by a Registered Student Organization that serves as an overarching group of RSOs representing student populations of an identity that correlates with the Caucus.
 - a. A Caucus may increase the number of ex-officio seats through a majority vote. The Caucus may appoint a new permanent member if that RSO disbands, or another overarching RSO emerges, with a 2/3 vote.
 - 2. Two (2) non permanent ex officio shall be filled by RSOs for terms coinciding with the
 - Senate Session. In relation to a Caucus's List of Applicable Registered Student Organizations: a. If there are three (3) or fewer RSOs that represent students of a specific identity,
 - those RSOs can serve one (1) year long consecutive terms.
 - b. If there are four (4) RSOs that represent students of a specific identity, nonpermanent ex officio members will serve staggered two (2) year non consecutive terms.
 - c. If there are five (5) or more RSOs that represent a specific identity, non permanent ex officio members shall not serve consecutive terms.
 - 3. Caucus ex-officio membership shall not count against quorum; however, it shall count for it.
 - 4. All ex-officio caucus members shall have full debating and voting privileges.
 - **5.** Ex-officio members shall **serve one (1) year-long terms.** be permitted to fulfill their entire term in accordance with guidelines in effect at the time of their most recent election.
 - 6. If an RSO with an ex-officio seat disbands during its term, the seat shall be vacated.
