 - i. Speech
 - (a) We are very familiar with this bill, it had to be pushed back due to the censure. As you can see, I made some additional amendments just sot hat it does not enroach on the current duties of the Justices. As it stands, it says that no Justice of the Judicial Council may provide advice on matters related to the Student Government Constitution or Statutes outside of official Judicial proceedings or

meetings. In addition, just as they are prohibited from serving as advisors in front of the Judicial Council. The other amendments for judicial council are for simplicity. In addition, it says that justices have a working understanding of the overarching documents and must complete annual training by the Chief Justice guided by the Student Government Advisor. As stated previously, we had several members of the Senate body with concerns involving the previous Judicial Review with regards to an internal bill and the part the Chief Justice played into that. The question was if they served as an advisor in place of the Judicial Advisor, and interpretations made which falls under the Attorney General. The Judicial Council gets final say, and so if they are interpreting as individuals without going through a hearing, then the Judicial Council becomes less of a Council and more as another 14 Attorney Generals. In addition, many Justices had trouble naming parts of the Election Statutes during questions earlier in the semester, which is very concerning coming from the individuals who are supposed to be interpreting these documents. If they aren't required to have that working understanding, then how can we hold them accountable? Senators must be familiar with these documents. I believe that this is a fair standard to enforce upon the Council and provide a better division between the roles of the Judicial Council and the Attorney General.

 - 1. Internal Bill 56-33 [Updates to Title XIV and II] [Pro Tempore Morissette]
 - i. Speech
 - i. This makes several changes to how caucus appointments will be made as they are being kept outside of Title III. The first one being the Chair can remove any member of their caucus, and the Vice President now appoints members of Student Government Agencies to caucuses. The Election Commissioners will also eb able to resign themselves, but must still submit their resignations to the Supervisor of Elections. This also makes all Student Government agents include people working in OSI, rather than just people working in the office or leadership. It also makes caucus meetings in line with Title XII rather than Sunshine Law.

 - Collazo: I wrote this bill with the Pro Tempore to help expand who can be a member of a caucus. In my discussions with the OSI Director, he stated that caucuses were originally created for the purpose of advocacy and to connect to the student body. I think it is only fair that our Agencies are able to sit on these, especially members of the Multicultural Center. Currently, only the student

directors of the agencies are considered members of the agencies, which I do not believe is fair and hope that this will encompass more people. Hopefully this will also allow us to have an outreach project with these agencies through expanding that definition to allow more people to sit on these caucuses because it is a disservice to not have a true connection with them beyond the A&SF board, which is a tangential connection at best. I think this will also be seen favorably with Dr. Frame as she has also been suggesting that while programming is good, too much can be bad, and that we should be doing programming in collaboration with the agencies we already have present.

 Internal Bill 56-34 [Updates to Title XIV: The Student Government Caucuses] [Chair Varela]


- This bill is pretty simple, it is a change to how caucus ex-oficio seats work. It will remove the limit on them to streamline the election process, as a caucus chair I realize that the allotted seats was not enough to cover the student groups that our caucus serves, as my caucus represents transfer students, Downtown students, Rosen students, and Lake Nona students. Three seats is not enough to represent all of these students, especially the subgroups within all of these campuses. I am unsure if other caucuses have this same issue, but I do not think we should be arbitrarily limiting the number of ex-officio seats that may be present on a caucus. I also wanted to get rid of the rotating door of ex-officio seats, as I find it quite difficult to manage and fairly pointless.

- i. Courts: For 1401.3.E, it says the number of ex-officio seats shall not exceed the number of Student Government Agents on the caucus, but it also says the Caucus Leadership Committee may expand the number of seats by a majority vote. What do you mean the Committee can expand the number?
- Varela: Let's say the Arab Caucus has only 3 members and wants a fourth ex-officio seat. They would be able to go to the Caucus Leadership Committee to expand their number of seats to 4.

I believe that this bill is good and that the only note I would like to make is I am the one who put in the Caucus Leadership Committee may expand the number of seats, as I shared with Chair Varela that I don't believe it is fair that if a caucus only has one or two Student Government agents and wants to have more seats, I don't think they should be admitted unilaterally based off of my caucus experience
 - Benwick: I think this is a really good bill, I am not in any caucuses so I see this from an outside perspective where caucuses have definitely been treated as a red-headed stepchild by being outside of Senate. This would help to make them the blonde-headed stepchild and expand engagement.

3. <u>Internal Bill 56-35</u> [Updates to Title XIV: The Student Government Caucuses] [Chair Varela]

- Varela: This is a bill that would make the ICTC a permanent caucus. Currently is an ad hoc caucus which will expire at the end of the year. I believe it is necessary we continue our work due to serving as a forum for advocating for Lake Nona, Downtown, Rosen, and transfer students, which is a very wide body. I have already seen a change where we are now discussing expanding initiatives to other campuses, so the presence of mind that we are advocating for these other caucuses has been good. There has also been much more outreach for transfer students since becoming a caucus and drastically increasing the number of events aimed at these students, a very important demographic due to how much of the student body they compose. We also serve a very important role in the renovations of the Rosen campus as we serve as the voice of students and ensure that concerns such as dining are heard. We have also been collaborating with the executive branch to oversee the transition of the nursing program from the Connect campuses to the Lake Nona campus. This is a multi-year endeavor, so for the caucus to be dissolved would be a major harm to these efforts. We have also been working hard with the registrar's office to have more transparency with transfer students as to why they were denied. This is just a small amount of what we have addressed, and there are many more issues with which we as a caucus must continue to address.

Should be the first thing heard in a meeting after announcements, LJR should get an announcement separate from committee announcements pertaining specifically to the censure at the beginning of the Senate meeting so attempts to overrule an LJR denial can be seen at the beginning of the meeting rather than all the way in Internal Committee reports.
 - vii. Timelines and what is considered germane for speeches and questioning for both LJR and on the floor are unclear
 - viii. Nothing is laid out in the statutes concerning submission of evidence. As it stands, the Chair can admit new evidence which was not seen in the LJR Committee, and it is never stated when evidence must be submitted to LJR either.
 - ix. There is no procedure for recommending a penal action.
