 - i. Gaudio: Does this proposed Senate Rule actually do anything or is it just a statement of values?
 - i. Collazo: You have to follow Senate Rules, while they are just a set of values, enshrining them implies that you could be disciplined for violating them.
 - ii. Gaudio: Wouldn't this just be covered by the Code of Ethics? Why not update the Code of Ethics?
 - i. Collazo: I think that DSR Lazo's intention was to mimic what the Judicial Rules of Procedures state, where in the beginning there are ethical codes the justices have placed on themselves. I do concede some of these are already covered by the Code of Ethics, but I will not put my personal opinion into this until debate as this is not my bill.
 - iii. Benwick: MTD, APPROVED BY GC
 - iii. Debate
 - i. Benwick: I do think this is pretty well written, I will be voting in favor as I see it helping later for disciplinary reasons as it makes it more clear in formatting.
 - ii. Gaudio: I will be voting against this as to me this is grandstanding and enshrining a really nonenforcable set of statements into a set of rules that are meant to govern how the Senate functions. At the beginning of every Senate session we issue a Resolution stating the values of that Senate session, and if we wanted to go down a disciplinary route, violations of the Code of Ethics are censurable offenses. I just don't see the point of this and I think it's putting something where it shouldn't be.
 - Collazo: I'm kind of in a grey area, my take is that I do not see anything wrong with enshrining core values as they can be consistently changed with provisions such as the first Resolution introduced at the start of a Session. The Resolution we did at the

beginning had no enforcement, but specifically with the language of the bill, I agree with the missions statement and declaration of values. The problem I run into is the impartiality and neutrality, as placing that onto Senators kind of goes against that idea that we are able to not be impartial or neutral with regards to Senate business as we are expected to raise opinions and be partial for the people we represent. That is where I run into the problem. As an example, while LJR acts impartial with respect to disciplinary matters, to place that on all Senators though is a bit going too far. Our Code of Ethics already says no SG Agent may allow personal biases to influence a vote. I'm actually more in favor of retaining this special act, as I think we should talk to the DSR about potential amendments. I am having struggling to determine how to amend that code without hindering our freedom to not be impartial or neutral with some business.

- iv. Jolicoeur: I will be voting in favor of this as Senator Benwick has already put it how I could possibly put it, just to add on though; I do not see any harm in adding this to the Senate Rules. From a writing standpoint, it just makes sense to be to be a sort of mission statement in the Senate Rules. While I could make the argument that this is possibly redundant as who doesn't already know this due to the Code of Ethics, I do think there is a purpose to it and if we need to address the code of impartiality further than we can do so but as a whole I see no problem with moving this forward.
- v. Trejo-Hernandez: I am in favor of postponing it, I find it a bit redundant but I do share the same sentiment with DLEG Collazo about how we cannot be expected to be impartial when we exist to represent constituents. I know that I represent College of Engineering & Computer Science and so I have those interests in mind.
- vi. Collazo: Move to see my amendments. Approved by GC
 - i. Speech
 - The first one is to strike out the specific and random actions, and so I modified them to be more broad and tailored to encompass everything related to Senate matters. I also added that not all Senate

matters demand neutrality and encourages using professional judgement in determining when it is necessary. I know that DSR Lazo was also looking for more sentences, hence the addition to the middle. At the end, this mandates that the rule shall be reviewed at the beginning of each Senate session to reflect those evolving standards as each Body is different and should be constantly updated.


