- o Justice Appointees this week. Quick note about that.
- I would like to take a moment to clarify an important point that some people may not be aware of. The services provided by the Judicial Council, specifically those related to Student Conduct and Academic Integrity (SCAI) advising and grade appeals, are subject to strict privacy regulations under the Family Educational Rights and Privacy Act (FERPA). As such, Justices are not permitted to receive training or participate in these services until they have been officially confirmed and subsequently trained by the SCAI administrators. With the upcoming confirmations of Associate Justices, I want to ensure that everyone understands this protocol. While the appointees have been thoroughly briefed on the external aspects of both processes, they have not yet had the opportunity to observe or participate in actual advising sessions. I hope this provides some clarity regarding our procedures and the safeguards in place.
