 - i. Meeting the presidents of the 2 clubs, this will be a mediated and refined event. There will not be any lashed-out arguments. This will be a positive event to promote their values and what they are interested in. Meeting with other clubs and leaders on campus will be explored.
- f. Rickett: Can you tell me how many seats are in Florida House and Senate?
 - i. I am unable to answer the question currently, but I would love to do research.
- g. Rickett follow-up: As GAC what is the process for setting up the DATC event and logistics? Working into selecting individuals?
 - i. Pending confirmation, I don't have access to budget currently, would love to bring in as many UCF students, would have a process to ensure that students are prepared to talk with legislatures. Bringing SGLCers to DATC was a wonderful experience as an SGLCer. Using a vetting process.
- h. Lipner: Please describe what you will be doing in the first few weeks when you are confirmed?
 - Get in touch with GAP committee Chair and Vice-Chair and to see what they want to do. Get in contact with our administrators and representatives at Gray Robinson. All of that would be fast, but the first week will be building relations.

 - i. Do not have access to budget, we do have a good relationship with the vendors from the past year. Will take leadership from each branch to downtown day- up for discussion. I like to take as many people as possible.
- k. Gaudio: Do you have any ideas on handling food for DATC, accommodations for dietary decisions?
 - i. Do not have access to budget, use the Little Cafe in the Capital, must investigate this to see the details. Anyone with dietary restrictions will be questioned through the vetting process. Rest assured that there will be substitutes for those who need them.
- I. Rickett: Last year there were issues with GAC and GAP not seeing eye to eye, how would you mitigate or change the dynamic and work better with GAP?
 - i. Pending confirmation, the first few weeks will be building relations with GAP Chair and Vice-Chair, working in tandem with the committee. I want to have collaboration on the student advocacy agenda, amazing to have them on my side. Value their opinions and look forward to building that relationship.
- m. Rickett follow-up: Tell us any of the initiatives or policies or legislation that we will see at the legislative session?
 - i. I do not know for the upcoming session, aware of 584... aiding students with homelessness or in the foster system, they will be in priority.
- n. Reed: Expand further on the Rally and Talley and Big 12 on the hill ideas, is it all UCF students or a select group?
 - It will have leadership from the branches for the Rally and Talley. The biggest thing is learning what other universities are doing and seeing how to benefit students at UCF. Big 12 on the hill is a unique experience, 2nd year doing it, broadening our range of advocacy. Get to go to D.C. and be with other universities. Get to advocate for legislature in Washinton.
