 - 1. Speech

- a. Lipner: In your opinion, how would you balance your own interpretation with precedent?

- a. Lipner: Could you include your rationale for implementing a law subset for the Judicial branch rather than another resource?
 - i. It would be more accessible on the SG website. Going directly to the Judicial Branch and seeing that there is a place for law students to receive than getting those resources elsewhere. As an individual who is first generation, having these resources on an easy website makes it very simple for anyone to access these resources which if it did go through- would include different pdf files, podcasts, YouTube links, etc. Including past law events with the Judicial Branch and having the names of the judges and attorneys on the website. With this, they can go and see if they can contact this individual. Ultimately, having that subsection on the website would be beneficial for easy access.

 - i. When I thought about the proposal, I thought of JOC. I am thinking of joining JOC for that reason. If we could take 5-10 minutes of the committee's time to come up with the different resources that we can find and implement with the help of our Judicial Outreach Committee.  - 1. Speech
 - a. Gaudio: This was something that was caught by Vice-Chair Trejo-Hernandez. Last year the Supervisor of Elections was internalized by the Election Commission. The issue is that there was no one who took chair for the Commission- so they couldn't elect a supervisor where there is no chair. This Bill allows the E&A Committee Chair to preside on the first meeting until the Supervisor of Elections is

elected and once they are elected, they must immediately select a Vice-Chair.

- a. Lipner: Where does it say the duty would fall to the E&A chair, and why not have someone else selected for this position rather than the E&A Chair?
 - i. Gaudio: In the bill, "a Senate designated committee chair" was included into Title VI, and in one of the Senate Rule changes passed last session any designations for Title VI fell to the E&A Chair. The Vice President is over the Senate in the Constitution, the E&A committee is over the Election Commission in Statutes, so it made sense that the E&A Chair would preside over the first meeting.
- b. Kapinos: A question about the Election Commission itself- when do they first come together to meet for the first time?
 - i. Escobar: That would be during this meeting and after they are confirmed. Beginning of Summer B.
