 - a. Good evening, E&A. Thank you for giving me the opportunity to speak this evening. Today I am here before you for this position. I was born and raised in South FL, so when I transferred to UCF, I wanted to find a similar Latin community. Through JLC, I got further love for serving my community through their events- it was one of the most rewarding experiences in my career. Since joining the branch, the heart of my mission has stayed the same, everything else around me has evolved. I am determined to understand the organization that I became a part of. Throughout the commitment, I wanted to fully immerse myself and I joined every committee- I began shaping my vision into action. I want to make things more transparent for the Judicial Branch by making it more digestible

through social media. I learned how far I came and how much more this is still to do. In the future, I plan to continue to leave my mark in the judicial branch. I am very excited to advocate for whistleblowers in the election process- this process can harm students from being an advocate because they are terrified of retaliation. We can and should advocate for these students and as a judicial member we are bound through impartiality- nonetheless, we should uphold students' rights and though we are impartial, we cannot stop being advocates. 2. Question

- a. Rickett: Can you explain the parking appeals process?
 - i. A student will get a ticket; they will receive a response through parking services- we are the second level in terms of responses. We look at the case virtual/written that tells us about the case so we can continue looking at information. We vote as counsel to uphold what parking services said, we can reduce it to a fee of \$10 or remove it completely.
- b. Rickett: What are some of your statutory requirements for being a Justice?
 - i. Remaining fair and impartial. Serve as a mentor for SGLC and JLC. Serve on internal committees.
- c. Gaudio: With the whistleblower initiative, can you note how aggressively you will push for it? How will you wrestle that with impartiality?
 - i. One of the main things that I want to start doing is just to have an open conversation with Pro-Temp or Brodie to get a better understanding of what it should look like. I am not trying to make a big change or push. Something else I included, in the case there is a veto, I would recuse myself if there was a vote- since that would be impartial.
- d. Gaudio; How do you think that a Justice being more proactive will reflect on the Judicial Branch on a whole?
 - i. I don't think it's a huge push because when seeing it in person- an election appeal was brought to us because there was a violation of due process. In the statutes, the name and

contact need to be there. The filer ended up taking their name out because they were afraid for their privacy. There were a lot of questions addressing who they are. I don't want it to be something that reflects on the Judicial Branchit was something that I saw personally and thought it would be best to highlight that and advocate for students' rights. I could always recuse myself and I know I have a stake in this and cannot be completely impartial.

- **e.** Reed: In your opinion, what makes a successful and effective judicial panel?
 - i. The variety. Speaking from experiences, we have students from all different forms of life. Even when having simple conversations, we need to have varied views and seeing different views of an argument. I think that's what makes a panel special.

 - a. Good evening, thank you for meeting me today. I am honored to be here. 2. Question

- a. Rickett: Can you name some of the boards Justices serve on?
 - i. Student conduct, grade appeal boards, parking, fiscal administration, etc.
- b. Rickett: How many articles are in the UCF Constitution?
 - i. 6 articles: student body, legislative, executive, judicial, student affairs, and amendment process.
- c. Gaudio: One of your initiatives contains mediation. Can you see this something that you do on your own, any changes on statutes? What changes are needed?
 - I wasn't thinking of something that would be a new function. I was thinking that this could be done in an outreach event. We can do this now and again in the Charge on Chamber, but it is not a permanent function of the Judicial Branch.
- d. Reed: How would you ensure impartiality in cases that involve peers or acquaintances?
 - i. Whenever there is a conflict of interest, the Justice shall recuse themself and I would do the same in that case.
- e. Kapinos: The classroom marketing initiative, what is your process if you want to market in a classroom where a professor is rarely there or does not want to. Will you be working with professors or the Division of Communications?
 - i. This was something that I was thinking that the Judicial branch can expand outreach. Lounging with Lawyers were mostly students from the Legal Studies department because the professors outreached to students and communicated to

- g. Lipner: Did you look into any existing mediation services at UCF? How will your proposal differ from those sessions and trainings?
 - I was able to find out about a few mediation resources. I
 wanted it to be similar to RA mediations, if students still
 feel unsatisfied- students can come to us to note their
 dissatisfaction.
