- 1. Good evening. This resolution recognizes Juneteenth as a significant holiday commemorating the end of slavery in the United States, highlighting its historical roots dating back to June 19, 1865, when the last enslaved African Americans were freed in Galveston, Texas. It acknowledges the continued importance of Juneteenth in honoring the resilience of African Americans and promoting equity and justice. The resolution also notes the demographic representation of Black/African Americans nationally, in Florida, and at UCF, as well as UCF's first Juneteenth celebration in 2020 led by the Black Student Union. All in all, this resolution asks the University of Central Florida to officially recognize Juneteenth on June 19, 2025.
