and making a fair and transparent process. I want students to care about what's going on around campus. My 1st initiative is a voting campaign- getting more creative with visibility and tabling. We can have candidate connection events where they are low pressure events for candidates and students to meet, allowing people to be more invested. This kind of engagement also builds trust. I strive to make people feel included, and our voting should reflect on our diversity- we need to motivate our students to do so. Being part of EC would make these values present. I hope to serve and also make students believe in and participate in it.

2. Questioning

- a. Gaudio: Tell me the requirements to serve as the Assistant Supervisor of Elections.
 - i. Not sure, but I can refer back to Title 6.
- b. Gaudio: Can you tell me a few areas where tangible campaign materials cannot be distributed?
 - i. 4 areas that cannot distribute- front of SU, south side of Memory Mall, hallway of Pegasus Ballroom, etc.
- c. Gaudio: Can you tell me in your own words what preponderance of evidence is?

- d. Lipner: If a student wanted to get involved in SG but did not have prior experience, how would you describe it to them?
 - i. To get involved with SG, you would need to be a candidate-you would need 100 signatures and certified by EC. They need to have a UCF ID. There is a declaration week of candidacy, where they would be approved and we are allowed to have write in candidates, needs to be submitted by 5PM the last day of voting. From there, you have active campaigning. The EC would set up locations for polling-Monday through Wednesday: 8 AM 5 PM. The results will be verified after 5 PM on Wednesday (last day of voting).

 - i. The Senate process, I am not too sure, but I will refer back to Title 6.

2. Questioning

- a. Trejo Hernandez: Can you reflect on your experience with software tools?
 - i. I started my freshman year through the animation program; I had a lot of hands-on experience through Adobe software programs. I worked with Canva, procreate, and a lot of experience with digital software. With my experience, the biggest connection is with my experience in SG through high school. We designed t-shirts that we gave to the student body. We designed posters for all events- these experiences made me work with a team and as a student brand.
- b. Lipner: You mention the student brand- if confirmed, what would that brand look like in your mind and how will it come to life?
 - i. UCF already has a unique brand. Through social media, we have a distinctive social media representation. I will be communicating with other members of the team and seeing our shared vision going forward.
- c. Lipner: Looking at your portfolio, I see a wide range of styles. How do you want to translate those styles to the vision- what are your goals and how would you bring them to life.
 - i. I would narrow it down; I would want to have a harmonious look. My various styles depend on who I am creating for. If confirmed, I would have a unique blend of styles that would represent UCF.

 - i. I'm not particularly fond of it. It detracts from human creativity. I see it as a tool, and I don't want to use it in this role; I don't think AI can tie in with UCF students and create things from UCF students to UCF students. I don't intend to bring it into this role.
- e. Gaudio: There will be certain times when you are held to very strict deadlines like the EC and the election cycle. How will you handle being held to strict deadlines and prioritizing certain requests?
 - i. I think that time management is the heart of that, I want to represent all branches equally- it will depend on urgency. If it's an emergency, I will make sure to do it first because of the time constraints. We already have a system with deadlines and can lay out everything for us; we already have a timeline. For emergencies, we will have ready to be posted and templates to share that content.
- f. Gaudio: Do you have any tools or software's that you use personally to help you with your time management and own deadlines?
 - i. For the most part, agenda and planner, or outlook. I am a visual planner.

 - i. Being transparent with the decision and upfront. No one likes feeling blind-sided, focusing on the content and why we made this decision so students can get the most information possible and decisions coming up to it.

- a. Escobar: Now that we are closing out confirmations, if anyone has ideas about legislation, we can start discussing that. You can also come up with legislation if you want to discuss it before it's remand it. If you want to remand it, we can do that as well.
- b. Gaudio: There is one big legislative thing that E&A could do; E&A needs a comprehensive overhaul to make it more readable for candidates. Title 6, as it stands right now, is a bit

messy. The candidate information is halfway through Title 6. Thus, a candidate trying their best to follow the rules can be difficult- we should try to go and fix that this session.

- c. Trejo-Hernandez: How much is Title 6 part of EC and how much is E&A?
 - i. Chair Escobar: EC is up to page 7 and the tier violations with EC.
- d. Trejo-Hernandez: We can have appendixes for Title 6 to note what belongs to the E&A Committee and EC. Other idea, make them two titles.
- e. Gaudio: I can see the merit of making them into two titles, but they would be so intertwined and if we were to make changes- you would have to update two titles at the same time. I think appendices are better. The finance code, the most important thing for an RSO is in the appendixes- an RSO doesn't have to care about if it's not in the appendices. Here is the information that is directly relevant to you.
- f. Lipner: I don't see Chair Gaudio's points; everything follows a very clear deadline for the election. I think everything in that aspect is well laid out. I would be in favor of dividing the Title into sub-divisions where there is potentially more clear subdivision. I would keep the ordering the same to follow that chronological order- because when I read it, it does feel very clear.
 - i. Chair Escobar: It has been brought up by candidates and Shane about how Title 6 was. Not necessarily the order but the language and sections are hard to find- I think clarifying the language or appendixes would be good. We can continue our discussion because it's just figuring out what that would look like.
- g. Gaudio: I must say that our perspective or people who are familiar with the statutes, but from the perspective of an individual who has never seen Title 6 before, having talked to various candidates, it can be confusing to navigate. A big question that came up last year- if there is a run-off where does it say that only 2 candidates go to the runoff? It's not where it's describing the run-off but under the Supervisor, the information is too separated for new people to see the information.
- h. Lipner: I agree with you Gaudio, that's why I don't think we need to go through separation. It's just small details and cutting out things in the incorrect places.
 - i. Chair Escobar: This was one of my initiatives and clarifying things and moving stuff around to make Title 6 more clear. We have the binder where we can mark up the Title and ensure that we clarify stuff without removing things/adding things.
- i. Gaudio: It still talks about the presidential run offs under the EC.
 - i. Chair Escobar: We can keep working on things, in the meantime if anyone wants to update Title 6 or remove things, we can have a discussion around legislation or write legislation.
