In addition, I should not have to go and correct the director on information if she did not contact us about it beforehand, if she had communicated this issue there would be no comment. I also deleted it upon her request.
- vi. Saucedo: Think it's important to potentially have a Senate instagram, Exec is clearly favored. Would like something like what Chair Holmes currently does on her own.
- vii. Custis: 52nd discussed a Senate instagram. Ended up going with Senate Round-Up that described what happened in Senate. Not sure if that already happens
- viii. Tache: Disagrees about having our own instagram. If we just had a healthy relationship with Exec and Comms, we would be able to post
- ix. Galloway: Session in the past did make a Legislative Branch instagram. Got in a lot of trouble for the Senate instagram. Tache is correct. Made a flyer that has the link for the request forms that is in the Google Drive if you want something posted/your event promoted. All in one place. Turner is short-staffed right now with it just being her. SG Scoop used to be the ELA's thing. Didn't like it very much, kind of just sat in everyone's inboxes. Plans to create a newsroom page on the SG website that covers the highlights of every branch. Working on that currently.
