 - i. Reports of continuous incidents of DLeg Wangen being unprofessional and ineffective within committees. Investigation done to determine merit and potential disciplinary action
 - ii. Incident was at CRT meeting (date). KXR (RSO) came to request funding. DLeg Wangen asked if every member was doing research on the trip. Since only 3 individuals were, they were ineligible for the requested category. Unprofessional response, asked about during the meeting. Further asked during the recess, which further explained the issues. Issues with side conversations during CRT and doubt of being able to remain unbiased. Thinks DLeg Wangen has improved, but still has growth to do.
 - iii. Committee leadership was mixed, but many had nothing but positive. One chair stated they've had nothing but positive interactions, and that DLeg Wangen has been very helpful. Expression of distrust in staying unbiased, issues with tone and coming off aggressive.
