[Funding for 8 members of the United Nations Association to travel to the McGill Model United Nations Assembly 2023 in Montreal, Quebec from January 26th, 2023 to January 30th, 2023]


WHEREAS, The United Nations Association (UNA-UCF) has been a Registered Student Organization since 1997;
WHEREAS, The mission of UNA-UCF is to provide a forum to study and promote the fundamental basis of peace with justice, to encourage participation in the United Nations and other official international and regional organizations, and to promote the ideals of international cooperation;
WHEREAS, UNA-UCF members pay dues of \$25.00 per semester;
WHEREAS, UNA-UCF currently has 111 active, dues-paying members;
WHEREAS, The purpose of the McGill Model United Nations Assembly 2023 is to compete with other top university Model United Nations teams. Any awards will contribute to UCF's ranking on the national circuit;
WHEREAS, Model United Nations provides experience to participating students in the fields of diplomacy, debate, and the writing of formal documents. Students will learn about international relations and practice them first-hand;
WHEREAS, UNA-UCF will be lodging at the Le Centre Sheraton in Montreal, Quebec; and
WHEREAS, The United Nations Association received \$5,283.18 via CRT Allocation 54-072 and Fiscal Bill 54-08 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Fourth Student Body Senate of the University of Central Florida that \$3,411.50 be allocated to the United Nations Association from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by March 1st, 2023;
BE IT FURTHER ENACTED, That the United Nations Association may complete a Post-Funding Form and return it to the Operations, Review, and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That the United Nations Association completes a Verification of RSO Purchases Form by March 8th, 2023, as a condition of receiving funding.
