 - a. Martinez - Pronouns on Student ID Cards making them free.
 - i. Interested in putting pronouns in student ID cards and allowing people to be able to put their preferred name, also make it free of charge. Interested in reaching out to SJA and Multicultural Student Services.
 - ii. Jax: It's basically just the numbers that matter. It needs to be optional to make sure people aren't out yet don't have to out themselves. Also I believe that
 - iii. Martinez: Of course I would make it optional.
 - iv. Jason: Name change is more important than pronouns since that's often more final. How easy is it to change the name?
 - v. Jax: No process, just requested to change their name and they did.
 - vi. Martinez: Do they have to pay for it?
 - vii. Jax: Yes.
 - viii. Domino: Legal name change or preferred name change?
 - ix. Martinez: Preferred.
 - x. Borges: There is supposed to be a process for it, seems easy, but the link that you need to use to do it does not work.
 - xi. Martinez: Just to clarify then, the goal is now to get ID Name Changes and Pronoun additions optional and free. And also when people first enroll in UCF, just have a page asking what name and pronouns they want on the ID if they want to just change it.

 - xiii. Borges: Contact Registrar's Office,
 - 1. Undergraduate students must submit the form to the Registrar's Office (MH 161; 407-823-3100).
 - 2. Graduate students must submit the form to the Graduate Studies Office (MH 230; 407-823-2766).
 - 3. Employees have a very easy process for this on MyUCF that normal students do not have, consider asking about that.
