- 2. Shelleh/Tache: In Disability Coalition group chat, this individual is in it. Campbell, can you contact them?
 - a. Campbell: I can do that. Is it illegal for a professor to out a disabled student to another disabled student?
 - b. Ciresi: Section 504?
 - i. "Colleges and universities are required by Section 504 and Title II to provide students with disabilities with appropriate academic adjustments and auxiliary aids and services that are necessary to afford an individual with a disability an equal opportunity to participate in the school's program"
 - c. Campbell: doesn't just apply to universities anything using federal funds. Professor created group on Canvas called "disabilities." Every person who has accommodations is shown.
 - d. Temple: Reads 504, could potentially include universities but we would need an actual legal opinion on that. Might be a stretch.
- 3. Ciresi: Table this till next meeting, see exactly what this is violating. Invite them to the meeting, get an interpreter, etc. talk to the student.
 - a. Campbell: Student was me?
 - i. Tache: clarifies that Ciresi was referencing first situation. Please do research to see how you can file a complaint. We as UCF SG don't necessarily have the power to fix this, but reaching out and showing we care and can advocate could be good. Centering what they want us to do, and not us deciding for them.

 - Tache: ideas for how to make it more accessible, temperature, waiting in lines, etc.
 - 1. Cibula: Former Senator. Want to maintain fairness of getting there early. If someone was disabled and had some kind of marker so they can go somewhere else (A/C, sit down), but still maintains fairness of first come first serve.
 - a. Tache: reminds me of Universal's disability passes. They write down a time to come back and go on the ride while they go wherever they need to.

- 2. Yalamanchili: Universal Knights can, in general, be done more efficiently. As Cibula, they could wait in a safer location. These lines are not too kind to people with accessibility issues. Incentive for people to not cut the line, or dis-incentives to not cut the line.
- 3. Temple: have you spoke to Director of Student Affairs, as they control the program?
 - a. Collins: we want to hear the ideas.
- 4. Shelleh: From my experience as someone who has waited in line and has a disability and friends with disabilities. Ticket system didn't mean anything because you could just move into the line. The best system would be a Ticketmaster system, with a limited amount given to students registered to SAS who cannot wait in the line.
 - i. Tache: I think that's a great idea. Having a certain number of tickets in a virtual queue is good. It should happen well before the actual in-person line. We can gauge demand this first year. At worst, 500 people who couldn't wait in line have an opportunity.
 - ii. Cibula: SAS related tickets should be offered way before. Is there a certain reason for 500?
 - iii. Shelleh: based on SAS and Disability Coalition data, it's a small percentage of the student population.10,000 tickets given out, 500 is 5% so its a fair number.
- 5. Yalamanchili: I know that some people have migraines and a hot sun can trigger that can cause fainting. Most people in the lines did not have water on them. 2,000 water bottles a day is unreasonable, but having some kind of reserve of water is accessible in case of emergencies.
- Temple: snacks could be a good idea as well. Logistical feat for sure, but providing something could help. Students have to ask friends to get them food or leave and cut the line to eat.
- 7. Tache: We should brainstorm things regarding all of this. Disability is a spectrum, and when you're in challenging conditions there will be
