1. Hurricane response and relief

2. Speech

a. Freshman at UCF, fortunate to not deal with storm too much, but a lot of others are less fortunate. Personal problem with UCF's response to the hurricane could have done a better job with warning. Not sure if SGA has jurisdiction over this, but there should be a change going forward about what needs to be done about giving students enough time to move their belongings and ensure their safety. Have adequate time to arrange with families, as many do not have cars or ways to travel outside of the state without assistance. Recommended in letter that there should be legislation concerning specific time period between projected landfall of the storm, which can be used to help students.

3. Questions

a. McClellan: We are working on something right now concerning this (draft for resolution concerning UCF's response about the hurricane). A lot of what you are saying is what we are doing right now.

For specifics, you were asking about a specific timeline regarding hurricane landfall. Could you elaborate on the timeline?

i. More concerned about before the storm than after partially because of experience with classmates and

family. UCF was fortunate enough to not get hit, but others were forced to stay in shelters. I don't want students to be unprepared as a result of lack of response from the university. Asking for a potential timeline before landfall so that students can know what to do. This includes warnings from campus about when campus will close. Could also include more coordinated effort between on-campus housing and university administration to help students. Tower III had little concern over who was staying there and how prepared they were for the hurricane. Please send a resolution to the university to give more time about when classes will be canceled and when they will resume.

- b. McClellan: To follow up, the current resolution does have a part asking the University to create a plan for natural disasters, including shelter preparedness and accommodations. I can work with the authors to add a part specifically asking for a timeline (for before the hurricane). Students should definitely be aware of how to be prepared, as many students got hit hard. Some of these students don't have places to run away to in preparation for the hurricane. I will work on that, thank you for bringing that up.
- c. Barekman: When we are talking about timelines, the US commissions studies to find out what happened before hurricanes and to use those results to calculate what happens in the future. If SGA includes legislation to include an outside auditor (to review the situation as it happens) and see how much time people need for things in different areas of our institution. Figuring out the timeline and if we have the resources to help students before hurricanes would be beneficial
- d. McClellan: In response - sure! While I am DLEG, I wouldn't add anything to the legislation before. Talk to Tache about this, it will have to be accepted by him. It's not a bill right now,

so changes are suggestions that can be adopted pretty easily. With UCF making a plan, they will need to do research to ensure that it is upheld. We don't have to go super in depth, because it is their responsibility as a university to create the emergency plan. Also, we did pass legislation in the past - IE phase II of the arts center - the Spaces could be used as a hurricane shelter in the future. This could feasibly be done. 5 years is far too long to not have a plan, but the Spaces could be included in the resolution as another solution for students.

- e. Capozzi: Could we speak with Knights Pantry to help with food shortages, especially those who are on campus and cannot leave. UCF should provide food and water for those students before the shelves are empty in stores.
- f. Anderson: Will talk to PT and others to ensure that those supplies are distributed within 72 hours. Great idea.
