- xxxi. Hurrell: With the E&A no confidence, there was information that was not germane.
- xxxii. Borges: Yeah, that shouldn't happen
- xxxiii. Hurrell: It has been brought up and it isn't statutorily incorrect
- xxxiv. Borges: Historically, Senate Records show different things. The 52nd AG stated that anything that happened before a Pro Temp's accession is not germane. Senators' debate must be germane. When it comes to this no-confidence leaderships' NCs revolve around capacity as chair/vice chair. Nothing regarding actions as a Senator is not germane.
- xxxv. Tribble: Do you think it's fair to bring up personal matters?
- xxxvi. McClellan: I don't think so. Only limiting it to your capacity as an SG agent, I am on the fence.
- xxxvii. Borges: When it comes to my chair position, these people are given a greater authority
- xxxviii. McClellan: I'm still trying to figure where the lines are, and I don't think everything you did should be put under a microscope
- xxxix. Tribble: Who draws those lines?
- xl. Hurrell: It would be at the discretion of the chair...
- xli. McClellan: Decorum can be set by anyone. Should we define this in Statutes? We'll need word from the AG on this. As of now, I guess the interpretation rests with the AG of the 52nd, though the current AG should probably be taken into account.
- xlii. Hurrell: If a Senator goes like "They hurt my feelings two weeks ago," that's one thing; but if a leader is under no-confidence and he says something that could be held against them. Things being used against others does happen and it's wild. What is said on the floor should be considered.
- xliii. Borges: There is a difference
- xliv. Hurrell: I know, but it's a very weird line. But trying to delineate what good you did as a Senator.
- xlv. Hurrell: As for Financial Office/Budget Committee?

- xlvi. Borges: Well, as Pro Temp his job is to support the chairs and students, acting as internal leader. Asking the committee and caucus chairs is within his purview.
- xlix. Hurrell: But what if he did this as Acting Chair? What would your plan be?
- l. Borges: I would have to speak with him, and there's always context to such incidents. Then lay out a more productive plan of restitution and ensure this doesn't happen again.
- li. Hurrell: I see where you're coming from, but it's difficult to see where you're coming from but you gave him a non-compliance without discussing him.
- lii. Borges: The Pro Temp was tasked with writing fiscal bills, but he did not. The committee issued it with a majority vote.
- liii. Hurrell: I understand that. The threat of revoking funding is pretty big. That template could've been shunted on the prior chair. This is rather different.
- liv. McClellan: Can I see the draft?
- lv. Borges: It's accessible. However I've established that I shouldn't have sent that. If I was informed of it not being used ahead of time, I wouldn't have sent it. I would've responded otherwise.
- lvi. McClellan: I think you need to include it since it's public record
- lvii. Borges: Public Record aspects are considered already.
- lviii. Tribble: can you establish that by saying you were in the belief you could do it?
- lix. Borges: I was told by the former CRT chair she had used it, mentioned it repeatedly and instructed to do so under certain circumstances. I thought we were able to do it, but talking with Brodie I realized this was actually not allowed but it was never removed. I am not going to blame them, will acknowledge there was a gap in advising.
- lx. Hurrell: The emails are different though. Communication that their disrespect will be noted, I'm not sure if that's statutorily in line, but revoking the funds already is another ballgame. If someone is rude to their manager, that manager can't just revoke a certain privilege. If someone is being super disrespectful, we wouldn't approve such funding. However, a retroactive zeroing out is rather concerning.
- lxi. Borges: Clarification: the 53rd CRT Chair did note that she had used it and she would revive it.
