a. Resolution 54-XX [Resolution Advocating for Voter Registration at Freshman Orientation] [Senator Caldwell] (Will be 54-19)

i. Speech

UCF does a good job having polling sites but a big issue with Voter registration as there are hundreds of volunteers on campus chasing down students to register. We should have voting orientation for freshmen on campus. There are many hurdles that we can explain to students. Many of us in this room spend hundreds and thousands of hours registering people to vote. A Lot of us can do far more if people are already registered to vote.

- 1. Almenar: As someone who has worked with voter registration organizations, do you intend to work with such organizations?
 - a. Caldwell: Yeah, I am aware that the laws are strict, and there are countless third party organizations that register students. If UCF wants to register students, they have no trouble with getting staffers out there. If they want to bring someone outside in or

- b. Resolution 54–XX [Resolution Advocating for Lobbying Reform at the University of Central Florida] [Senator Caldwell] (54-20)
 - i. Speech
 - 1. Similar to the others, What makes voter participation not impact democracy is the legalized system of bribery in America, lobbying. In this case students over University. UCF spends 160,000 dollars a year in lobbying funds. It goes to a lobbying firm. UCF does not disclose where the lobbying effort goes too. We only get a statement that 160,000 dollars went to lobbying. UCF has some influence over the government with this money that students don't know about. This resolution is about making this more transparent and having the university relying on faculty and student body senate to approve spending.
 - ii. Question

 - a. That we could try to shift this, but the board of trustees allocates all this. What this would look like is the administration talking to us on what they want to lobby on. They have the power to do this.
- 4. Almenar: I agree with the sentiments of the bill, but since the reactions you've received were nonexistent, do you think they'll pay attention to this and actually act on it?
 - a. Caldwell: I think most of you know it centers around organizing and this is one aspect of the campaign. We are doing similar campaigns surrounding getting support from SGs across the nation and getting them to sign onto Youth Power Pledge, demanding such transparency and showing the university we care about it and that it is worth it making this more transparent. This is one facet of many, and our pledge has gotten 500 signatures, likely more. We're going to continue this.
- SGLCer Rubenstein: Regarding one of the bill's Clauses, lobbyists do have to publicly disclose their actions. Moreover, the 160,000 appears to not be from a total expenditure, but rather individual
 - a. Yes I can answer to both, yes lobbyist have disclose they're the meetings but the corporation does not have to disclose who they lobby too, this is more for have more transparency where our money is going too. For the private donations these things get conflated. He can assure that this is not private, it is UCF.

- Tache: This is the most important of the resolutions, it should be a general consensus among us that this is important. We have a limited power compared to other SGs and since we have a dedicated

- 3. Holmes: I commend Caldwell for this, and seeing him spearhead the fight against this issue is encouraging especially after the midterms
- 4. Yalamanchili: I will support, students want to know where their money goes and they want a say on the matters that are being discussed and where there money is going.
- 5. Almenar: I too am in support, I did want to discuss more about the fact that UCF spends a lot and we don't know where this is going, but I also want to talk about FSU and UF. They have a significant amount of control over their lobbying agenda over their secret societies and their oversized influence. People from those societies calls ours the most democratic because of that lack of secret societies. So maintaining and expanding the democratic aspects of this initiative will help.
- 6. Caldwell: So UCF has Spend 2.7 million lobbying since 1998 in comparison we spend less than lobbying but we have less power in lobbying compared to other institutions.
