 - We had our first A&SF Budget Committee meeting yesterday, October 19th. We held chair and vice chair elections and are currently in the process of determining the next meeting time, as well as which budget committee members will represent what entities.

 - Borges's Budget Fact
 - The Great Defunding of 2014.
 - Due to a reduction of \$1.3 million dollars from the total A&SF Budget between fiscal years 2014 and 2015, the following occurred:

- Late Knights was nearly zero-funded by the A&SF Budget Committee in 2013 as they received a nearly \$150,000 cut from their \$180,000 budget. The effects of this cut still remain today.
 - The Campus Activities Board received a nearly \$90,000 cut.
 - Homecoming took a nearly \$40,000 cut.
 - The Executive Branch took a nearly \$80,000 cut.
