 - Day at the Courthouse yesterday was amazing, shoutout to Governmental Affairs Coordinator McLain! It was great seeing some of y'all there.

- Thank you all for having me at your retreat this past weekend! I appreciate the opportunity to increase education and awareness of our statutes. As always, if you have any questions about anything related to statutes, but perhaps not one that needs an official opinion, feel free to come speak to me or email me about it.

- Spring election time frame (these were reviewed at the retreat, but one was slightly off, so wanted to include the correct dates and times here, per Title VI):
 - Candidate packet: January 9th - February 10th, 2023 at 5:00 p.m. (603.2)

- I'll be meeting with Pro Tempore Foster, DLeg McClellan, and Chief Justice Kehr next week to discuss Title IX, address any faults in the statute, and begin drafting changes to it.
- I've been reviewing Title VI and compiling an outline with all important dates and deadlines to assist EC.
- There is a pending opinion request regarding votes of no confidence.
 - It will be published next week.
- Internal Bill 54-24 [Updates to Title IX: Adding Documents Censures may Reference]
 - I've done some research into the scope and limitations of collegial bodies, such as UCF SG, and to what extent we are able to sanction and condemn actions in an official manner that fall under state and federal statutes or legal mandates.
 - I'll share some additional commentary regarding why this Bill is out of our purview, and even if passed, it is not enforceable. We, as students, are not attorneys or police officers and therefore, are not able to interpret or enforce state and federal law.
 - If there was an issue arising between two SG agents or an allegation against an SG agent, there are streams of justice available—including SCAI, OIE, IntegrityLine, Victim Services, Student Care Services, CAPS, University PD, Student Legal Services, etc.
 - Beyond that, this Internal Bill would jeopardize persons due process rights, by attempting to turn this chamber into a de facto court of law.
 - I'm more than happy to meet with anyone to discuss this further and find a way to address relevant concerns without jeopardizing the integrity of our governing documents by extending beyond what we can do.
