 - **Attorney General (Caitlin Moore, sga_ag@ucf.edu)**
 - Hello Senate! I'm currently at Winter Wonderland, but here are some updates from me.
 - The SGLC Holiday Banquet and Council Reveal earlier this week was so much fun! I'm so glad I was able to attend and shoutout to all the SGLCers who now are in their Leadership Councils!
 - I met with DLeg McClellan to discuss Title IX and have some ideas for recommendations for revision.
 - [Title VI: Outline, Timeline, and Deadlines for the 2023 Election](#)
 - I finished reviewing Title VI and compiling an outline with all important dates and deadlines to assist EC and sent that to Supervisor McGregor.
 - I also found more areas of Title VI that can use updating and am preparing that as well.
 - I've been finishing the outstanding opinion request, I should have that out to you all soon.
 - Internal Bill 54-24 [Updates to Title IX: Adding Documents Censures may Reference]
 - I've done some research into the scope and limitations of collegial bodies, such as UCF SG, and to what extent we are able to sanction and condemn actions in an official manner that fall under state and federal statutes or legal mandates.
 - This Bill is out of our purview, and even if passed, it is not enforceable. We, as students, are not attorneys or police officers and therefore, are not able to interpret or enforce state and federal law.
 - If there was an issue arising between two SG agents or an allegation against an SG agent, there are streams of justice available—including SCAI, OIE, IntegrityLine, Victim Services, Student Care Services, CAPS, University PD, Student Legal Services, etc.
 - Beyond that, this Internal Bill would jeopardize persons due process rights, by attempting to turn this chamber into a de facto court of law.
 - I'm more than happy to meet with anyone to discuss this further and find a way to address relevant concerns without jeopardizing the integrity of our governing documents by extending beyond what we can do.
