 - Hello Senate! Tonight is the last night I appear before this body as Attorney General...
 - Official Business:
 - I have published an opinion regarding tonight's censure. This opinion makes the censure null and void and cannot be seen during this Senate meeting. Another censure must be submitted with the mention of a specific statute in order for it to be considered valid.
 - I have also received two other questions regarding First Amendment constitutional protections. I am not an attorney and cannot provide this Senate or any other body/individual with legal advice. Nonetheless, only as an educational matter, I will present the questions posed and present a simple, yet paramount commentary. Here are the questions (amended only in grammar and for clarity's sake):
 - Is censuring someone based on protected speech under the First Amendment unconstitutional?
 - Is the insinuation that one should abandon religious liberties to avoid further censures an unconstitutional breach of First Amendment protections?

- The Supreme Court interprets the First Amendment to protect even offensive ideals. In Matal v. Tam, a unanimous Court concluded that "[the government then] offend[ed] a bedrock First Amendment principle: Speech may not be banned on the ground that it expresses ideas that offend." Thus, this irreversible opinion should provide useful commentary on the rationale this Senate should use when proposing disciplinary actions against an individual.
- I do not defend the transphobic commentary of any individual and find them unpalatable. While these actions are reprehensible, they fall within the realm of protected speech.
