 - a. Hello everyone! Happy Wednesday!
 - b. Student Priorities Survey 2022-2023
 - i. Our primary goal today as a committee is to finalize the format of the Student Priorities Survey and vote as a committee on the final form of the survey. Excited to hear input and discussion!
 - c. Upcoming Juneteenth Celebration at UCF!
 - i. Hosted by MSC and the Cultural Center on 06/16 in the Live Oak Ballroom.
 - ii. Event begins at 2pm with performances, attractions, food, and organizations!
 - d. This past Sunday was the official 6-year anniversary of the Pulse Nightclub Shooting.
 - i. There is still work to do to make sure that those we lost are not lost in vain. Continue to honor them with action in your daily lives.
 - e. Last Sunday was also the 55th Anniversary of Loving Day.
 - i. Loving Day celebrates the anniversary of the landmark 1967 Supreme Court Case *Loving v. Virginia* which struck down bans on interracial marriage in a unanimous decision.
 - ii. Acceptance of interracial marriage has gone from 4% in 1961 to 94% in 2021 according to Gallup.
 - iii. While not enforceable since 1967, the final interracial marriage ban on the books was removed in Alabama in 2000. The vote was 59% to 40% in favor of removing the ban from the state constitution.
 - f. Jimmy Carter Fact of the Week:
 - i. Jimmy Carter ran in 1976 on pardoning the men who evaded the draft during the Vietnam War.
 - ii. Proclamation 4483 and Executive Order 11967 was signed by Jimmy Carter on his first day of office that officially pardoned all those who evaded the draft from between 1964 to 1973.

- c. Just as a quick SITREP:

- 1. Chair: Time is assumed to be in the evening. Other services will be tabling (LGBTQ+, MSC).
- c. Student Priorities Survey 2022-2023 Template
 - i. This template was created on Google Forms so that everyone could take a look at it. The final survey will either be made through Qualtrics or possibly another medium due to issues with Qualtrics last year.
 - ii. LINK to the Template.
 - iii. Discussion:
 - 1. Chair: le: When students filled out what issues they were passionate about, Qualtrics deleted it.
 - 2. Chair: This nixxed a lot of potential rationales for interest.
 - 3. Chair: Maintain anonymity, a good idea since it can be used to trace back to the person (people) who filled it out. Asking major will help in getting an even spread of colleges. We have a series of different issues that were more appropriate that would be asked, working with SBA Chair and Sustainability Coord (former GAP VC). Tried to specify yet remain broad (one was too broad). Added more to awareness of DATC question (including adding the term "Day At The Capital"). We plugged both committees to ensure that both committees are advertised.
 - 4. Chair: How should we rank?
 - 5. Almenar: Just a template?
 - a. Yes. To clarify, we hope to finalize it and next week we will determine what platform we ought to use.
 - 6. Almenar: How long will they have to be polled?
 - a. W/o a GAC, we have as much time as we can. The GAC set a deadline for the 53rd Session's GAP. Want to explore the Day At The County. Ideally up to early Fall we will run this.
 - 7. Simko: Speaking of DAT County, should we plug that as well?
 - a. Only reason why we may not is because we haven't finalized it. This survey is principally for DATC, but it could be used later for such event.
 - 8. VC: Are we adding a question that would ask the student to explain their rationale for their choices?

- a. The only reason why it isn't there is because it would be too time-consuming. Students aren't as likely to answer it since it would be way too long. It can be optional.
- 9. Simko: I think these topics can be rather broad. Such as taxes. How will we know what we will lobby for?
 - a. This is fair. These were taken from last year. We can change that one, but we need to balance the flexibility we have to advocate. (Education, Economy also fall under this).
- 10. Domino: Agrees with Simko on broadness, will there be a backend process to know exactly what we would advocate for?
 - a. We could find ways to reach out directly to the students with an additional survey to gauge interest in the broader topics.
 We can also narrow the focus on these topics.
- 11. PT: I would suggest adding another question that would explain that issue more thoroughly.
 - Agreed. Similar to what VC stated. Should it be optional or required? Mandatory: will get concrete answers, but not as many respondents; Optional: vice versa
- 12. Yalamanchili: Optional. The more opinions we get, the more balanced policy issues we can get. Passionate people will outweigh the general majority.
- 13. Castelin: Echo Yalamanchili; from experiences prior, more people will complete the survey with fewer, simpler questions.
- 14. Damarla: I was thinking something fun we can do is that we can have a physical activity accompany this. Something engaging physically will bring more people.
- 15. Domino: Bouncing off of PT Ciresi, maybe they can suggest a few hot button topics underneath the umbrella term. These terms can be divided under multiple choices.
- 16. VC: Word limit to their explanation
- 17. Simko: Data for survey from last year?
 - a. I believe we do. The number was not high.
- 18. Simko: The numbers were not very high last year, we ought to address.

- a. Chair Clarification: The Qualtrics was weird, COVID still reigned. GAP had a much harder time advertising it. Including some engaging activity would be of great benefit. The survey itself isn't the issue, it was the timing. A question of how best to promote the survey is a good one to discuss.
- 19. Chair: General consensus over explaining certain topics. Lots of personal promotion. If we do decide to make it optional, we can say it is "highly encouraged" that they answer the question. Beyond that, the survey seems comprehensive enough. We can proverbially go back to the drawing board and wrap this up by next week. Messages will be prevalent in GroupMe, so keep an eye out for that. The broadness can make it difficult since a lot can fall under the umbrella we might need to talk about.
- 20. Chair Borges: As of now, if you want to use a Google Form, they might be able to send multiple forms to skew results
- 21. Clarification: We have it on Forms temporarily. Qualtrics was just really weird and skewed already due to their omission.
- iv. Follow-up: Regarding distribution, I would love to help. Rosen in particular would be a keen target.
 - 1. Gotta make sure it isn't main campus heavy. DT, Rosen are affected by transportation more so.
- v. ELA: The Qualtrics doesn't eliminate skew either. People were able to submit their emails, which weren't tied to forms. Not entirely possible to maintain anonymity.
 - 1. Bots can invade and skew things...we do NOT want that. To emphasize, we are still searching for a perfect medium
- vi. Domino: Chair Borges reminded me of DT's need, and I would be more than happy to spread the word around in DT.
 - 1. Agreed. We can get input from Lake Nona.
- vii. ELA: Chair Borges and I are planning events to tour sister campuses. Regarding DT, the best way to have students heard, the best way is to schedule a 1:1 with the ELA. (TL;DR: Necessary (if shameless) ELA 1:1 plug)
