- iii. <u>Internal Bill 54-11</u> [Updates to Title XI: Mandate of Workplace Harassment Training for Student Government Agents][Chair Hall]
  - 1. Speech
    - a. Thanks to y'all for letting me come. It is straightforward. There is no requirement outside of paid positions for workplace ethics training. I believe it is important that we all take it. Workplace harassment takes place e retry where in America and it is important that everyone here feels safe. I hope nothing happens but we have to prepare. The training requires the trainings to be separate. The ethics and workplace harassment training should be separate to help people grasp the information. The training itself is at the discretion of the Speaker and leadership to see what this would look like. This bill doesn't mandate what it will be just that it must exist. This is more so for the next session and going forward. This sets the standard going forward.
