- ii. Today is also Helen Keller Day, which celebrates the birthday of one of America's most influential women. Ms. Keller was born OTD in 1880 and was notable for her activism for individuals with disabilities, for women's right to vote, for labor rights, and for world peace, among many, *many*, other subjects, and her catalogue of writings on a equally expansive subject matter, despite herself being blind and deaf from the age of 19 months. For her efforts, she would awarded the Presidential Medal of Freedom and be inducted into Alabama's Women's Hall of Fame and Writer's Hall of Fame in 1971 and 2015, respectively.
