- 11. Member Discussion
 - a. Yalamanchili- I have talked to former senators who were LJR members and from what they have told me that the last LJR committee was more lenient. They did grant personal excuses and for unforeseen circumstances to an extent and when i told them how we do it now it was their opinion that we were strict. I do not believe this is concussive to the well being of senate. The idea of precedent is irrelevant and we can approve requests as we see fit. We should not worship precedent.
 - b. Wangen- I do want to put last years LJR committee into perspective they approved blanket excuses that were statutorily not allowed. Precedent is not always great, having been in ORS we tried not to set any. We should reevaluate the policy.
 - c. Urea- I think the fact that exec overturned the absences they should factor in.
 - d. Galloway- As a former member of LJR basically was how we did it was we set a memo for ourselves for what we would and wouldn't approve so we can have everyone aware of what would or wouldn't be approved generally. We excused wedding and gave one mental health day, we should do something like this again to let everyone know.
 - e. Urea- we did do a precedent sheet but we can change it.
 - f. Tache- I want situational analysis. I tend to be the most lenient voter but today I was prepared to deny Grace's absence. It was only one absence at the end. But she has done great work. I would vote in favor of it if it was to set her over the edge. I know that we have done that that we approve
