 - 1. Speech
 - a. This just changes the definition of student at large this was just done by the branch heads and I noticed that the President would choose and the other branch heads would just agree. - b. Borges- I talked to Speaker Custis about the general idea of Students-at-Large and she said she is open to changes. She had no official stance on my bill.
- c. Urea- this doesn't change anything right?
- d. Borges- this changes a lot technically. This doesn't change things in practice but it does statutorily.
- e. Yalamanchili- So this internal bill does not weaken the legislative and judicial branches authority. It technically gives power to the President to choose solely but that is just how it is already in practice. This bill does however give us the opportunity to confirm them. The Chief Justice would technically have less power.
- f. Urea- If you wanted more power with the speaker and Chief Justice wouldn't you not remove this and enforce the old way.
- g. Borges- it isn't that I don't want that but I feel having them confirmed is better than just two other individuals
- h. Yalamanchili- would such a student at large go through E&A
- i. Borges- I believe that this would qualify

3. Debate

- a. Urea- I think the bill is good so I will vote yes but I am not sure about on the floor
- b. McClellan- same sentiments
- c. Yalamanchili- I can't vote but I am not sure how I would vote on the floor. I am traditionally skeptical about shifting power in favor of exec and this seems to move power away from the speaker but I think this is a reasonable idea. Confirmation does take longer however. I do not feel strongly in any direction about this.
