WHEREAS, Human Factors and Ergonomics Society (HFES) has been a Registered Student Organization since 1998;

WHEREAS, The mission of HFES is to facilitate discussion of their discipline, assist students with professional development,

disseminate information, and to increase awareness of human factors and ergonomics;

WHEREAS, HFES members pay dues of \$10 annually or are members of the national society;

WHEREAS, HFES currently has 18 active members;
