## University of Central Florida Fifty-Fourth Student Body Senate Fiscal Bill 54-05

[Funding for Chabad Jewish Student Group to host the High Holidays at Chabad, from September 25th to September 27th, 2022]

**WHEREAS**, Chabad Jewish Student Group (Chabad) has been a Registered Student Organization since 2007; **WHEREAS**, The mission of Chabad is to open the door of Judaism to all students and faculty on the UCF campus, we have established The Chabad House, a place where Jews of all backgrounds and degrees of observance can enjoy exploring their Jewish

heritage in a warm, welcoming and non-judgmental environment;

WHEREAS, Chabad currently has about 100 active members;

**WHEREAS**, The purpose of the High Holidays is to host High Holiday services, traditional dinners and spread cultural awareness and diversity to the students at UCF;

**WHEREAS**, Hosting the High Holidays contributes to the cultivation of a more culturally-inclusive and diverse campus experience by allowing students to interact with other students from different backgrounds;

WHEREAS, The expected turnout for High Holidays is 400 individuals; and

WHEREAS, Chabad Jewish Student Group received \$0.00 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.

**THEREFORE**, **BE IT ENACTED**, by the Fifty-Fourth Student Senate of the University of Central Florida that \$9,633.07 be allocated to Chabad Jewish Student Group from the Senate Working Fund according to the following breakdown:
