[Funding for 12 members of the Future Theme Park Leaders Association to attend California Executive Management Shadow Week in Anaheim, California from December 11th, 2022 to December 18th, 2022]

WHEREAS, Future Theme Park Leaders Association (FTPLA) has been a Registered Student Organization since 2004;

WHEREAS, The mission of FTPLA is to develop future leaders for the Theme Park Industry by providing educational, professional, and networking opportunities;

WHEREAS, FTPLA members pay dues of \$55 annually;

WHEREAS, FTPLA currently has 146 active, dues paying members;

WHEREAS, The purpose of the California Executive Management Shadow Week is to immerse chosen members into a week of high-level theme-park learning experiences including site visits behind-the-scenes to learn and understand management structures, policies and procedures, and tools and systems that are being employed in California theme parks while speaking with and learning about the careers of very successful park presidents, managers, and more;

WHEREAS, This conference provides a unique opportunity for FTPLA members who went on the trip to share their learnings to the rest of the members during their Spring semester meetings, in which they can explain the differences between well-known Orlando parks and the California parks in terms of their forms and functions of management and with California's unique challenges and differences:

WHEREAS, FTPLA will be lodging at Knott's Berry Farm Hotel in Buena Park, California; and

WHEREAS, Future Theme Park Leaders Association received \$0.00 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.
