Fiscal Bill 54-15**

[Funding for 6 members of Moot Court at UCF to travel to the Eastern Michigan Regional Tournament in Ypsilanti, Michigan from November 18th, 2022 to November 20th, 2022]

WHEREAS, Moot Court at UCF has been a Registered Student Organization since 2013;

WHEREAS, The mission of Moot Court at UCF is to foster a community of students who share an interest in the law, to allow for discussions of constitutional issues, and to develop advocacy skills through participation in scrimmages and tournaments;

WHEREAS, Moot Court at UCF members pay dues of \$90.00 annually if they are new members and \$45.00 if they are returning members annually;

WHEREAS, Moot Court at UCF currently has 18 active dues-paying members;

WHEREAS, The purpose of the Eastern Michigan Regional Tournament is to argue constitutional law in a simulated Supreme Court to qualify as many teams to the National Tournament;

WHEREAS, Competing at the Eastern Michigan Regional Tournament will enrich the UCF competitors, allow them to network with other high-quality advocates, and bring prestige to UCF as a bastion of legal studies;

WHEREAS, Moot Court at UCF will be lodging at the Hampton Inn & Suites Ypsilanti in Ypsilanti, Michigan; and

WHEREAS, Moot Court at UCF received \$0.00 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Fourth Student Body Senate of the University of Central Florida that \$2,458.05 be allocated to Moot Court at UCF from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by December 20th, 2022;

BE IT FURTHER ENACTED, That Moot Court at UCF may complete a Post-Funding Form and return it to the Operations, Review, and Sanctions Committee (ORS); and

BE IT FURTHER ENACTED, That Moot Court at UCF completes a Verification of RSO Purchases Form by December 27th, 2022, as a condition of receiving funding.
