
WHEREAS, Trial Team has been a Registered Student Organization since 2004;
WHEREAS, The mission of Trial Team is to provide students with the opportunity to focus the skills required for litigation through national competition;
WHEREAS, Trial Team members pay dues of \$150.00 per semester if they are a new member or \$125.00 per semester if they are a returning member;
WHEREAS, Trial Team currently has 24 active, dues-paying members;
WHEREAS, The purpose of the Third Annual Aggie Invitational is to compete against other schools and further improve upon trial advocacy and public speaking skills;
WHEREAS, The students competing in this tournament will get to proudly represent UCF and exhibit the skills they are constantly perfecting;
WHEREAS, The students will be able to learn more from watching other teams compete and will hopefully bring back some trophies;
WHEREAS, Trial Team members will come back to UCF with further improved trial advocacy and public speaking skills;
WHEREAS, Trial Team will be lodging at the Holiday Inn Express & Suites in Fort Worth, Texas; and
WHEREAS, Trial Team received \$0.00 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Fourth Student Body Senate of the University of Central Florida that \$4,652.64 be allocated to Trial Team from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by February 14th, 2023;
BE IT FURTHER ENACTED, That Trial Team may complete a Post-Funding Form and return it to the Operations, Review, and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That Trial Team completes a Verification of RSO Purchases Form by February 21st, 2023, as a condition of receiving funding.
