[Funding for 44 members of Student Physical Therapy Association to travel to the American Physical Therapy Association Combined Sections Meeting in San Diego, California from February 22rd, 2023 to February 26th, 2023]

WHEREAS, Student Physical Therapy Association (SPTA) has been a Registered Student Organization since 1995;
WHEREAS, The mission of SPTA is to promote the awareness of the physical therapy program on campus and in the community, facilitate the growth and wellness of physical therapy students, and provide volunteer services throughout the community, thereby furthering continuing education of physical therapy students;
WHEREAS, SPTA members pay dues of \$200.00 annually;
WHEREAS, SPTA currently has 111 active, dues-paying members;
WHEREAS, The purpose of the American Physical Therapy Association Combined Sections Meeting is to attend three days of educational, evidence-based, sessions from all physical therapy fields (i.e. orthopedics, sports, neurology, geriatrics, pediatrics, and acute care) and to network with professionals, researchers, students, and faculty involved in the fields of physical therapy across the country;
WHEREAS, This conference provides opportunity for students to speak about the caliber of research produced within UCF's DPT program with other students, clinicians, and faculty members at the national level;
WHEREAS, UCF students bring back awards each year from presenting at this conference;
WHEREAS, SPTA will be lodging at the Holiday Inn Express in San Diego, California; and
WHEREAS, Student Physical Therapy Association received \$0.00 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.

THEREFORE, BE IT ENACTED, by the Fifty-Fourth Student Body Senate of the University of Central Florida that \$22,552.20 be allocated to Student Physical Therapy Association from the Registration and Travel Account according to the following breakdown:

BE IT FURTHER ENACTED, That all unspent funds revert to their originating account by March 27th, 2023;
BE IT FURTHER ENACTED, That Student Physical Therapy Association may complete a Post-Funding Form and return it to the Operations, Review, and Sanctions Committee (ORS); and
BE IT FURTHER ENACTED, That Student Physical Therapy Association completes a Verification of RSO Purchases Form by April 3rd, 2023, as a condition of receiving funding.
