[Funding for Chabad Jewish Student Group to host the Mega Shabbat in the Pegasus Ballroom, on February 24th, 2023]

WHEREAS, Chabad Jewish Student Group (CJSG) has been a Registered Student Organization since 2007;

**WHEREAS**, The mission of CJSG is to open the door of Judaism to all students and faculty on the UCF campus and establish The Chabad House, a place where Jews of all backgrounds and degrees of observance can enjoy exploring their Jewish heritage in a warm, welcoming, and non-judgmental environment;

WHEREAS, CJSG currently has 1,000 active members;

WHEREAS, The purpose of the Mega Shabbat is to host an annual event which brings cultural diversity and awareness to campus, making campus more inclusive;

WHEREAS, Mega Shabbat will allow UCF students to gain cultural awareness and experience an authentic Shabbat Dinner;

WHEREAS, The expected turnout for Mega Shabbat is 500;

WHEREAS, Chabad Jewish Student Group received \$9,633.07 via Fiscal Bill 54-05 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.

**THEREFORE**, **BE IT ENACTED**, by the Fifty-Fourth Student Senate of the University of Central Florida that \$9,350.00 be allocated to Chabad Jewish Student Group from the Senate Working Fund according to the following breakdown:
