[Funding for Chabad Jewish Student Group to host the Passover Seders at Chabad House, on April 5th, 2023]

WHEREAS, Chabad Jewish Student Group (CJSG) has been a Registered Student Organization since 2007;

**WHEREAS**, The mission of CJSG is to open the door of Judaism to all students and faculty on the UCF campus and establish The Chabad House, a place where Jews of all backgrounds and degrees of observance can enjoy exploring their Jewish heritage in a warm, welcoming, and non-judgmental environment;

WHEREAS, CJSG currently has 1,000 active members;

WHEREAS, The purpose of the Passover Seders is to enable students to celebrate Passover while away from home;

WHEREAS, Hosting Passover 2023 will bring cultural awareness and diversity to campus and make it more inclusive and diverse;

WHEREAS, The expected turnout for Passover Seders is 450; and

**WHEREAS**, Chabad Jewish Student Group received \$9,633.07 via Fiscal Bill 54-05 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.

**THEREFORE**, **BE IT ENACTED**, by the Fifty-Fourth Student Senate of the University of Central Florida that \$11,136.39 be allocated to Chabad Jewish Student Group from the Senate Working Fund according to the following breakdown:
