[Funding for 7 members of UCF Daytona Student Nursing Association to travel to the National Student Nursing Association in Nashville, Tennessee from April 12th, 2023 to April 17th, 2023]

**WHEREAS**, UCF Daytona Student Nursing Association (UCF Daytona SNA) has been a Registered Student Organization since 2016;

**WHEREAS**, The mission of UCF Daytona SNA is to assume responsibility for contributing to nursing education in order to provide for the highest quality health care and provide programs representative of fundamental and current professional interest and concerns and to aid in the development of the whole person and their professional responsibility for the health care of people in all walks of life;

**WHEREAS**, UCF Daytona SNA members pay dues of \$47.00 annually;

**WHEREAS**, UCF Daytona SNA currently has 38 active, dues-paying members;

**WHEREAS**, The purpose of the National Student Nursing Association is to prepare students for initial licensure as registered nurses, convey the standards and ethics of the nursing profession, and promote development of the skills that students will need as responsible and accountable members of the nursing profession;

**WHEREAS**, It would also be a good networking opportunity for UCF nurses to be able to expand outwards into other states;

**WHEREAS**, UCF Daytona SNA will be lodging at the Gaylord Opryland Hotel and Convention Center in Nashville, Tennessee; and

**WHEREAS**, UCF Daytona Student Nursing Association received \$0.00 in Activity and Service Fee Funds in the 2022-2023 Fiscal Year.

**THEREFORE, BE IT ENACTED**, by the Fifty-Fourth Student Body Senate of the University of Central Florida that \$3,155.70 be allocated to UCF Daytona Student Nursing Association from the Registration and Travel Account according to the following breakdown:

**BE IT FURTHER ENACTED**, That Student Nurses Association completes a Verification of RSO Purchases Form by May 24rd, 2023, as a condition of receiving funding.
