[Updates to Title IX: Removing Office Supplies]

WHEREAS, Statutes require constant updates and revision to best serve the Student Body;

WHEREAS, Office Supplies were removed as a Budget Line during the Forty-Seventh Session of the Student Body Senate, and that is reflected in Bill 47-78;

WHEREAS, Since the Financial Allocations for Organizations cannot Non-compliance anyone for something that does not exist, this power should be removed from Title IX; and

WHEREAS, This Bill will go into effect immediately.

THEREFORE, BE IT ENACTED, by the Fifty-Fourth Student Senate of the University of Central Florida that Title IX be amended as follows:

Chapter 901 Authority to Issue Notification of Non-Compliance

901.1 The authority to issue a “Notification of Non-Compliance” is vested in the following offices:

- A. The Student Body President,
- B. The Student Body Vice President,
- C. The Student Government Comptroller, in instances where the infraction impedes the Comptroller’s ability to perform their duties,
- D. The Attorney General
- E. The Chief Justice
- F. The Judicial Council, by a majority vote
- G. The Supervisor of Elections, with jurisdiction limited to the Election Statutes and the election proceedings.
- H. The Senate President,
- I. The President Pro Tempore,
- J. The Student Senate, by majority vote, and
- K. The LJR, ORS, FAO, CRT, and E&A Committees of the Senate, by majority vote, under the following jurisdictions:
 1. The Legislative Judicial and Rules (LJR) Committee shall have jurisdiction over all statutes and Student Government legislative actions, except for the allocation of Activity and Service Fee Funds, the Finance Code, and the Election Statutes.
 2. The Operations Review and Sanctions (ORS) shall have jurisdiction over the Finance Code.
 3. The Financial Allocations for Organizations (FAO) Committee shall have jurisdiction limited to the Senate Working Fund and ~~Office Supply~~ accounts.
 4. The Conference Registration and Travel (CRT) Committee shall have jurisdiction limited to the Registration and Travel accounts.
 5. The Elections and Appointments (E&A) Committee shall have jurisdiction limited to the Election Statutes and the election proceedings.
