[Proclamation Celebrating Eid al-Fitr 2022]

**WHEREAS**, Senate Rule 5.01(D)(1) states that Proclamations are defined as measures celebrating extraordinary events, organizations, or individuals on behalf of all Student Government Agents;

**WHEREAS**, Eid al-Fitr marks the end of the Holy Month of Ramadan;

**WHEREAS**, Eid-al Fitr is a celebration time for Muslim students;

**WHEREAS**, Eid al-Fitr is recognized as one day;
