[Updates to Title VI: Adding Election Commission Seats]

**WHEREAS**, Statutes require constant updates and revision to best serve the Student Body;  
**WHEREAS**, The work of the EC is complex and requires many volunteers;  
**WHEREAS**, The more people who can work on an election and provide insight, the better off EC will be; and  
**WHEREAS**, This Bill will go into effect immediately.

**THEREFORE, BE IT ENACTED**, by the Fifty-Sixth Student Senate of the University of Central Florida that Title VI be amended as follows:

Chapter 601 The Election Commission

601.1 Membership

The Election Commission's membership shall be composed of ~~ten (10)~~ **fourteen (14)** students from the University of Central Florida.

- A. The Supervisor of Elections will have served as an Election Commissioner at UCF for a minimum of one election period. The Senate may overturn this prerequisite by a 2/3 vote.
- B. The Supervisor of Elections and an Assistant Supervisor of Elections shall be appointed, from within the Commission, by the Student Body President to serve a term which ends the last week of Summer A.
- C. Commission members may not hold any other elected or appointed Student Government positions, with the exception of caucus leadership positions.
- D. ~~Five (5)~~ **Seven (7)** Election Commissioners shall be appointed each year. If a vacancy occurs, the president shall appoint a replacement to serve the remainder of the term.
- E. Commission members' terms of office shall run for two (2) consecutive Executive Administrations.
  1. Commissioner Seats ~~#1-5~~ **#1-7** shall be appointed no later than the last week of Summer A of every even year (e.g., 2012)
  2. Commissioner Seats ~~#6-10~~ **#8-14** shall be appointed no later than the last week of Summer A of every odd year (e.g., 2011)
  3. This pattern shall continue perpetually
