

[Updates to Title XIV: The Student Government Caucuses]

WHEREAS, Statutes require constant updates and revision to best serve the Student Body;

WHEREAS, As of now, the Sustainability Caucus has the Ad Hoc status;

**WHEREAS**, The Caucus has been a vital platform for advancing environmental, social, and economic sustainability initiatives within Student Government;

**WHEREAS**, The Caucus has played an instrumental role in coordinating the Cultural Sustainability Market, fostering collaboration between cultural RSOs and sustainable development efforts;

WHEREAS, The Caucus has built strong and ongoing relationships with key campus leaders and departments, including Director of Housekeeping Amy Childs, Director of the Arboretum and Sustainability Initiatives Jennifer Elliott, Coordinator of Arboretum Programs Kelsie Johnson, Coordinator of Sustainability Initiatives Ryan Chabot, Interim Dean of the College of Undergraduate Studies Dr. Wayne Bowen, Director of Landscape and Natural Resources Travis Simmons, Business Services Manager of Auxiliary Services Scott Eberle, Aramark District Manager Christina Loughren, and Senior Manager of the UCF Athletic Village Patrick Butler; WHEREAS, The Sustainability Caucus has fostered broad collaboration across Student Government by supporting other caucuses and committees through the integration of the United Nations Sustainable Development Goals (SDGs) into legislation, offering guidance on sustainability-related issues, and providing insight on campus initiatives where environmental and social sustainability intersect with student advocacy;

WHEREAS, The challenges of climate change, environmental justice, and sustainable campus development will persist and evolve, demanding ongoing representation within and across Student Government; and

WHEREAS, This Bill will go into effect immediately.

**THEREFORE**, **BE IT ENACTED**, by the Fifty-Sixth Student Senate of the University of Central Florida that Title XIV be amended as follows:

Chapter 1401 Caucuses

1401.01 Student Government shall recognize the following caucuses at the first meeting of the Student Body Senate following the start of the Summer B semester:

- A. Asian/Pacific Islander Caucus
- B. Black Caucus
- C. Disability Caucus
- D. Inter-Campus and Transfer Caucus
- E. Latin/Hispanic Caucus
- F. LGBTQ+ Caucus
- G. Military & Veterans Caucus
- H. Sustainability Caucus
- I. Women's Caucus
