WHEREAS, Through his church, Pedro volunteered much of his time and even became a certified Stephen Minister to help counsel others;
WHEREAS, His aspirations were to pursue his Masters and to become a Licensed Social Worker and Therapist to continue serving others;
WHEREAS, Pedro was a beautiful young soul, and he led his life with unconditional love and time for others. His favorite hobbies included learning from others, reading many books, and playing video games with friends. Above all, he always made time for his family, whom he loved dearly;
WHEREAS, He has been a constant inspiration for all UCF students;
WHEREAS, The UCF community has suffered a great loss with the tragic and untimely passing of Pedro; and
WHEREAS, UCF shall remember Pedro with honor and respect.

THEREFORE, BE IT RESOLVED, That the Fifty-Fourth Student Senate of the University of Central Florida acknowledges and remembers the life of Pedro; and
