[Proclamation In Memory of UCF Student Chrioni E. Lenertz]

**WHEREAS**, Senate Rule 2.04(G)(1) states that the Student Body Advocacy (SBA) Committee shall pass measures advocating on behalf of the student body regarding student and university affairs at the University of Central Florida (UCF);  
**WHEREAS**, Senate Rule 5.01(D)(1) states that Proclamations are defined as measures recognizing, celebrating, or condemning extraordinary events, organizations, or individuals on behalf of all Student Government Agents;  
**WHEREAS**, Chrioni E. Lenertz is remembered by friends, family, and fellow students as an exemplary person and member of the UCF community;  
**WHEREAS**, Chrioni was proud to be a student at UCF, pursuing a graduate degree in Public Policy in the College of Community Innovation and Education;  
**WHEREAS**, Born 10 weeks early in St. Paul, she was named after a book about a warrior angel with the name Chrioni;  
**WHEREAS**, Before coming to UCF, Chrioni was a 2002 graduate of the US Merchant Marine Academy (USMMA) and was a proud member of the USMMA Regimental Marching Band. She worked as a Merchant Marine officer for Military Sealift Command (MSC) and sailed for a year abroad USNS Tippecanoe;  
**WHEREAS**, Her favorite memories came from her time in Hawaii, as well as in Greece and Angel's Landing in Zion National Park.  
**WHEREAS**, Chrioni touched many lives and made a great impact on her community.  
**WHEREAS**, She thrived on helping the local Oviedo community by volunteering at The Hope Chest Thrift Store Boutique;  
**WHEREAS**, She has been a constant inspiration for all UCF students;  
**WHEREAS**, The UCF community has suffered a great loss with the tragic and untimely passing of Chrioni; and  
**WHEREAS**, UCF shall remember Chrioni with honor and respect.

**THEREFORE, BE IT RESOLVED**, That the Fifty-Fourth Student Senate of the University of Central Florida acknowledges and remembers the life of Chrioni; and  
**BE IT FURTHER RESOLVED**, That a copy of this Proclamation be sent to the family of Chrioni at the Eternal Knights ceremony in an effort to show family members that they are not alone in this difficult time and that the UCF community will cherish Chrioni E. Lenertz's memory.
