- Attorney General's Report (Jorge Altuna, sga_ag@ucf.edu)
 - Good afternoon, Senators, Thank you all again for confirming me. I'm truly excited for the year ahead and incredibly grateful for the opportunity to serve alongside each of you. For today's report, I'd like to walk you through a few key updates and initiatives I've been working on. First and foremost, I'm proud to share that the Student Government Statutes have been fully updated. When I entered this role, one of the most pressing issues was the significant backlog of unincorporated legislation. The statutes had not been updated to reflect around 40 pieces of legislation passed during the 56th session, beginning with SB 56-22 concluding with SB 56-72. Thanks to the incredible cooperation of OSI, we were able to expedite the upload process, and the updated statutes should now be live on the Student Government website. Please note: this turnaround was only possible due to their extraordinary support, and future updates will take a few days to reflect on nQueue as normal. This past week, I had the opportunity to attend and report at my first LJR Committee meeting, and I want to thank Chair Gaudio and Vice Chair Trejo Hernandez for their warm welcome and leadership. I look forward to a productive and collaborative year with them and the entire committee. Additionally, I've met with Speaker Courts, who has been incredibly helpful in reviewing statute language and clarifying questions. On the judicial side, I've connected with Interim Chief Justice Bella Pazera and the Justices, I'll be shadowing future student case hearings and joining portions of judicial orientation and various of their trainings, particularly on topics like parking appeals and SCAI. I'm currently drafting a compliance calendar for the Executive Branch to help track monthly reporting requirements and key deadlines. I've in the process of completing ethics and sunshine training through the Florida Commission on Ethics. Earlier this week, I sent an email to branch leadership and committee chairs to open a line of communication and provide direct access to the statutes. If you have any questions about internal legislation or would like clarification on specific titles, please don't hesitate to reach out. And if you happen to notice an error or anything that might have

been missed in the codification process, feel free to text or email me, and I'll make any corrections right away! Looking ahead, my next priorities include Updating the Senate Rules of Order, launching a public submission form for Attorney General opinions, and updating any new legislation passed today and signed by President Blanco and Dr. Frame. Thank you again for your time, your service, and your trust. I'm here to support you however I can and I look forward to working closely with all of you throughout the year.
