seconds or wait, however in committee it was seen that when you ask you get more responses at least while you're testing it out. If you're seconding something, you do not need to be recognized by the chair. When a motion is made, you can call out a second. If a motion is objected to before a second, we go into debate on the motion. For transparency, track who seconds each motion in the minutes. When a motion is seconded, you must state what the motion is. If a motion is not unanimous, you can move to debate even if there is a second. If you ask for an objection you are assuming it will be unanimous agreement. Objections are directed to the amendment not if the amendment should be seen. Don't ask for objections, it's too weird. Ask for objections if you think it is unanimous. Objections should be used for procedural errors or if the motion should not be seen at all by the body.
