1. Speech



- **a**. Lipner: Already have discussed this bill before. Just writing out the procedures to ensure that every student who needs a name change can get a name change and avoid potential violations.

    - i. Bill passes first reading in E&A.
- ii. Internal Bill 57-10 Updates to Title VI.docx
  - 1. Speech
    - a. Gaudio: Motion to adopt this bill in committee.i. Adopted.
    - b. Escobar: Cleaning up Title 6 for run-off elections. Last year, we had a bill where presidential elections we have ranked voting. This removes all mentions of run-off presidential elections because of past legislation. It's cleaning up Title 6.
  - 2. Questioning
    - a. Rickett: If there is a situation and there is no mention of a run-off election in statutes. How would the judicial branch be able to look at any piece of legislation or Title statutes to see if there are any problems with a runoff.
      - i. As it stands, there is no run-off with presidential elections because of past legislation.
    - b. Rickett: So, there will be no way there would be a runoff in any circumstance?
      - i. In the bill we passed last session, there are no runoffs for presidential elections. However, senatorial elections still have runoffs. But since there are no presidential runoffs because of our previous legislation.
    - c. Kapinos: Technical question; this legislation was submitted 24 hours to the Pro Temp, correct?
      - i. It was not.
    - d. Kapinos: Do you still want to see this bill even though it was not submitted in advance?



- i. Hameed: Don't need to interject.
- ii. Gaudio: Because we adopted the bill in the committee, we do not need to submit it 24 hours in advance. Pro Temp just needs to be notified in advance.
- e. Lipner: Question to either Chair Gaudio and Chair Escobar, was the portion about run-offs that we discussed before- removed this session or past session? Or should we update that as well. When looking for statutory backing for the top 2 presidential candidates-would it be in a different title?
  - i. Gaudio: It in Title 6, it was in a completely different section of Title 6- specifically under the Duties of the Election Commission. I think that section is still there.
- 3. Debate
  - a. Gaudio: Move to see my amendment to see Chapter 604.3 D 1.
    - i. Speech
      - 1. Gaudio: What I'm doing is reinstating that text but only removing run-off. It's unlikely but there is a possibility that at a ranked vote that there is a straight tie, in that case there is no reconciling that with the current language. If there is a tie (including ranked choice) we have some sort of reconciliation.
    - ii. Questioning
      - 1. Chair Escobar: Does it make sense to keep it under the session or another session?
        - a. Gaudio: Could make more sense to put it in another section technically.
      - 2. Rickett: Can we specify the top 2 tickets in an event of a tie.
        - a. Gaudio: The provision is not in there, but with ranked choice- it will narrow down to the top 2 in itself. It would be redundant to add.
        - b. Lipner: Specifies that we are looking at the tied two tickets if that's your concern, it's provided within the statutory wording. I would be in favor of changing the D1 into E if that makes sense.
      - 3. Rickett: Move to debate.

1. Rickett: Move to vote/I move to the previous question.

a. Lipner: I object.

a. Chair Escobar: I second that motion.

    - i. Escobar: I also talked to the DCOS- there are interviews this week and next week, there are some happening today. If they are favorable, we will see confirmations next week- hopefully we will see them before the end of the summer if all is well.

  - c. Gaudio: I will have a discussion with the Pro Temp, I want to pass a resolution to form an ad-hoc committee to see whether or not it's feasible to increase the AS&F budget- cross collaboration on this committee. If any of you guys are interested, let me know and I will keep you updated.
  - d. Rickett: Does anyone know any of the potential confirmations, if any are grad students?
    - i. Gaudio: With current appointees, there are no graduate students- but there is a graduate student that is enrolling in the Fall who is interested in joining SG (they can't fill out the form because they are not in UCF yet). I did give them a small nudge to start before Fall.
  - e. Lipner: Regarding the AS&F fee in that ad-hoc committee. Do we know if the Comptroller will be involved directly.
    - i. Gaudio: He is fully on board.
    - ii. Chair Escobar: Do we know the name for this committee.
      - 1. Gaudio: No because I am bad at naming things.
        - a. Kapinos: AS&F Budget Revision Committee?

a. Amendment passes in E&A Committee.



- b. Gaudio: I like AS&F Revision Committee for conciseness.
- f. Gaudio: The Committee pushes the process of raising the AS&F budget, when an entire committee shows that they want it.
  - i. Lipner: I think that we should not call it a revision committee, which makes it feel disingenuous. It feels like the Comptroller's role is to do this.
    - 1. We can discuss this on the Senate floor then. Additionally, we do not know whether the resolution is going to be passed yet.
