- a. Rickett: If this is enacted, do we have to amend every statute past Title X?
 - i. Chair Gaudio: This changes the title numbers. The AG would also fix it.
- b. Rickett: Do we need to amend every other statute that references Title X?
 - i. Chair Gaudio: It is an AG issue. When we strike it from the statutes we also set a new order for the statutes. Example from when we made Senate Rule 1, the rest moved with it as stated in the bill.
- c. Rickett: In Title VI, it says candidates need to meet requirements in Title X. Do we need to update that?
 - i. Chair Gaudio: Title 10 is explicitly mentioned in Title VI. I will add that in there.
 - ii. Motion for AG Altuna to speak
 - 1. AG Altuna: Under statute 402.18 it allows me to correct small errors without senates consent. This could fall under that so I can update that.
 - iii. Rickett: It could fall under the AG's jurisdiction, but I don't consider this specific situation to be under that.

 - a. So this resolution is removing the voting rights of the supervisor of elections or their designee from the E&A committee. So for context this was added in the 55th session. The main reason I'm looking to remove this is because we as senators are elected by students to represent them through our votes on legislation. The supervisor of elections is not an elected sg agent and their purpose is to not represent students. Their purpose is to oversee the election commission and make sure we have a fair and transparent election. Due to this, I see their role in E&A as more of an advisor. They should be encouraged to give their input on certain things that would affect them and their branch however I do not think they should be able to vote on legislation.
