 - i. <u>Internal Bill 57-05</u> [Updates to Title XII: Minutes Submission Deadline] [Senator Barnes]
 - 1. Speech
 - a. I present this bill today to update Title XII to include a minutes submission deadline for all branches and committees. Currently, there is no specific timeframe in our statutes that require prompt submission of minutes. This makes it harder for students, and members of this body, to access timely records of our meetings and discussions. This bill will establish a clear and consistent deadline for submitting minutes, ensuring we uphold our commitment to transparency for our student body. This bill adds language to Chapter 1201 that would require minutes to be submitted to both the branch head and the Student Government Advisor within five academic days of a meeting. This gives enough flexibility to review and finalize minutes, while also ensuring that they are made available to the public without unnecessary delay. The intention is not to create an extra burden, but to provide consistency across SG and to reinforce expectations that already exist around recordkeeping and transparency.

a. 9-0-0, Bill Passes LJR

- b. Resolutions
 - i. Resolution 57-05 [Striking of Senate Rule 1] [Chair Gaudio]
 - 1. Speech
 - a. Gaudio: This strikes senate rule 1 in its entirety. This was passed at the very end of the last session. It serves as a code of values for us. It is not a rule, there is nothing actionable within it. The beginning of the session is very chaotic anyway. We have a resolution posted up anyway in the office. We already have the code of ethics. Title 11 is actionable, this is not. If we want this we can post our resolution publicly.
 - 2. Questioning
 - a. Hameed: When was this enacted and put into statutes
 - i. Gaudio: June 19th, 2025.
 - 3. Debate
 - a. Hameed: I'm going to be debating this bill as it serves a different purpose from Title XII as it has a code of neutrality which Title XII. This was instituted last month and not even waiting it through is kind of a disservice to last session. For more context, the Senate President and I were considering discussing this at the Senate Retreat and looking over the Resolution to update it or go through it based off our experience as a lot of new Senators have come to the session and didn't really know what to put on there. That would be turned into a Resolution to change this Rule to give it the purpose it was meant to have. The plan is already in place, also technically the Resolution that we have in Orientation, we can't hold anyone to this. This makes itself we can hold ourselves to it, and I think that's important because we are all accountable for the things we promise to each other. I don't think this is a thing we should be doing, we should give it more time to see if it serves us and revisit this, but I do think it is useful in what it adds and that it has a purpose.
