- ii. <u>Internal Bill 57-04</u> [Updates to Title III: Updates to Media Training] [Pro Tempore Hameed]
 - 1. Speech
 - a. This all happened because with this new addition of media training, i was trying to figure out how media training can be completed within 10 days for current or new senators. When ELA Reed brought her version of media training through a canvas course, presentation, etc. We realized that is not conducive for media training, you can't do it by yourself while watching a video- you need to interact with someone else. The 10 academic days would strain our ELA and Pro Temp office. At the beginning of Senate, most people in leadership/office would not be able to make it, thus it would be rushed. Additionally, someone would have to talk to you about it, and there is a caveat in statutes that would state that you would not participate in interviews. The 10 academic days would not make sense, and there are Senators who do not participate in interviews. If they are not going to be interviewed, they have that choice. It is sponsored by the ELA as well.
 - 2. Questioning
 - a. Diei: It's making sure that it's not required but encouraged, and also that it's not within 10 days and that you can do it before an interview?
