- a. The JRP has the roles for most roles justices hold with the exception of committee vice chairs. I was considering making a rule similar to 4.02 under section 4 but specific to Vice Chairs. I do understand that most of the position is implied and at times duties are mentioned within the committee rules themselves, but I think including a rule right under 4.02 (would then become 4.03) could benefit those unfamiliar with branch and bring clarity.
