 Good afternoon E&A, my name is Nghi Chau and I'd love to have the honor of serving as your Chair. This is a slide of a preview of what you can expect, I am currently a junior studying Legal Studies with a minor in Writing & Rhetoric. I am known for my current position as Vice Chair of E&A,

and through this I learned the intricacies of Student Government elections and appointments. Over the past semester, I had to take long detailed minutes over what we have covered. Because of this, I have had the opportunity toverview our documents, and I am so passionate about this committee. I stayed up until 1-2AM taking notes for this committee, and I want to retain that energy into being Chair. Some specific expectations we have so everyone knows I'm aware of what's expected, for instance, I do know I will have to lead and plan for our meetings as well as the implicit duties such as collaborating with committee members and SG as a whole to create initiatives to improve UCF's election processes. For my leadership style, I am currently the Vice Chair for E&A as previously noted, and because of this I was directly under the wing of Chair Escobar and could directly observe how he led this committee through forming close bonds and oversight. If elected Chair, I want to further this leadership style and this slide goes into how I plan on going about this. I want to go above and beyond for this committee through my leadership. If I become Chair, I'd want to continue Chair Escobar's current initiatives such as an overhaul of Title VI to make it more legible, such as groups of committee members over certain sections of Title VI with one senior member who understands statutes and two freshmen who can learn how to read these statutes and gain that experience. I also plan to hold discussions in committee to oversee these plans and coordinate among them. I also want to work with our Graudate Senators to develop specific methods of appealing to graduate students, and develop a close relation wwiththe Election Commission. I hope to sit on all of their meetings every week so E&A can understand their operations each week. so I want to develop this to have a smoother transition period. I know that because I am a fresher Senator, there is going to be a big pair of shoes I'd have to fill.

2. Question

- a. Rickett: Both of you have recognized the issues of graduate students, can any tell me why you think there is a lack of representation by them?
 - i. Chau: I think that when it comes to graduate students, the biggest constraint when it comes to maintaining a position in SG is the amount of extracurriculars and classes they have to handle while also handling Senate. It is a huge undue burden to maintain that position, so I want to see if there is any way we can accommodate them but also expand outreach in that regard. I do know that graduate students are mostly unaware of SG or how they can help, so I think it is for those reasons.
 - ii. Beneche: I'm actually going to take a different approach, we've already touched on lack of time, but I believe there is also a lack of interest. A lot of graduate students I've talked to through tabling with EC and they'd tell me they had genuine disinterest in SG. I think we just need to educate people on what we do and how fun it can be, and people may at least try to make some time to observe our proceedings. I just believe it really is a disinterest, as well as other extenuating factors.
- b. Rickett: Let's say you have a candidate that is going through the E&A process and wants to be appointed. In this scenario, you find the candidate is in violation of Title X. You, as Chair, what would you do in that situation?
 - i. Beneche: I think what I would do is call for them to be postponed, I'd talk to the chief of staff to see if there are any courses of actions we can take or if it can be amended, if we can't, then just telling the candidate we cannot see them.
 - ii. Chau: SO that's a really interesting question, and to first htink, let's say we realize this candidate they are not eligible during the committee meeting, we would have to postpone them and not only have a separate discussion with

- the deputy chief of staff to inquire what happened and what went wrong in that process. It would be in the procedural operations that it was our fault for not noticing they were not eligible.
- c. Lipner: We all love what Chair Escobar did, however you both mentioned things you want to do differently. What will you continue to do, and what will you discontinue that you may wish to approach differently from Escobar?
 - i. Chau: In terms of what Chair Escobar did that was successful, I think utilizing seconds during committee meetings did allow the meetings to run smoother, not only that but how he had a leadership style where he would facilitate conversations and allow other committee members to talk and take initiative when facilitating discussions. In terms of what he could have improved on, I do think he mostly had a successful run, I do think there were times that committee members were too tense and we need to remember to remain decorum before appointments, so mostly just staying more stern when reprimanding that behavior.
 - ii. Beneche: I'm going to completely echo the sentiments of Chau, I just feel like he did a really excellent job in the role and I take a lot of inspiration from him. I was asking him a billion questions about this role, and there wasn't really anything I could point out in particular that I did not like, but one thing I think is that we need to start being assertive when it comes to types of questions we're asking and how we are talking to people. There's a time and a place to have fun, but in front of these appointments we need to maintain our seriousness.
- d. What experience do you have in chairing a meeting, and are you comfortable taking the chair immediately?
 - i. Beneche: I do have experience in chairing a meeting, I've been the LGBT caucus chair for a year now, and I'm comfortable immediately taking the chair. I have nothing else to do besides class and watch Gossip Girls, so I could start right now.

Chau: I will admit that, in terms of chairing a meeting, I do not have any experience, but nonetheless I do feel i would be immediately comfortable taking hte chair as I have been reading the transition binder and would schedule meetings with the Senate President and Pro Tempore to discuss how to chair but also what specific things need to be kept in mind to successfully chair.
- e. Gaudio:: First question; for what reasons are you the E&A Chair are allowed to issue a censure
 - i. Chau: I do know that, there's an EC in violation for a specific reason, you can note a specific censure for whatever reason is. I do want to apologize if I recalled that incorrectly
 - ii. Beneche: I can issue a censure if performing unethical conduct, if there is repeatedly disruptive behavior and parliamentarian procedures. I'm not sure if there are others, but that is the main idea of being disruptive repeatedly.

- f. Gaudio: The Deputy of Chief of Staff said they would review senate application one a week, our first confirmation will now be seen in 24 days
 - i. Beneche: I'm pretty confrontational, I will have the conversation with Deputy of Chief of Staff and with the president to ensure that we get the representation that we need and will be sending daily emails. You need to apply the pressure to ensure that there is timeliness, People lose confidence in SG when they don't hear back
 - ii. Chau: I do agree with Beneche, I would have the discussion with the Deputy Chief of Staff and as long with LJR Chair to issue a notice of non-compliance to have some sort of repercussion to ensure that we are getting representation and timely responses.
- g. Gaudio: As E&A chair, what standards will you hold the EC accountable for any instances that you find questionable?
 - i. Chau: I would be reviewing the election statues, Chapter 601 for the EC. I know that we can issue a notice of non compliance and to ensure that we aren't getting anything questionable. We can also as a committee discuss if we

- ii. Beneche: I echo those sentiments, I'm confrontational, I'm experienced in disciplinary actions. I would do my research to see what actions what I could take.

3. Debate

- a. Gaudio: I believe both candidates are on fairly equal footing, as while they both have an understanding of Title VI, there is a lack of understanding for other statutes such as Title X and Title IX.
- b. Rickett: I echo what Senator Gaudio said before, I wasn't satisfied with either of their answers. They do have a vision and a want to help others. With the committee members and future members. I would be voting for Senator Beneche, as she has more leadership experience.
